Purpose of processing

Personal data will be processed by the Italian Society for Law and Literature (ISLL) - at the Department of Law - University of Urbino Carlo Bo, via Matteotti n. 1, 61029 Urbino (PU), tel. 0722.303200, e-mail: lawandliterature@uniurb.it.

Only personal data voluntarily provided by the data subject at the time of application, such as name and surname, e-mail address, profession and institution, curriculum vitae, will be processed. The activities of data collection and subsequent processing will be aimed exclusively at managing the membership request, entering the name and curriculum vitae on the ISLL's membership page on its website, and sending periodic updates on initiatives (in the form of a newsletter).

No advertising or direct sales material is sent, including for the purpose of carrying out market research or commercial communication.

Legal basis of processing

The legal basis of the processing is Art. 6(1)(e) GDPR; therefore the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the data controller.

Subscription to the newsletter is free and free of charge but, if the data subject subscribes to it, the provision of data is necessary and failure to provide it means that it cannot be sent. The interested party may unsubscribe at any time by writing to lawandliterature@uniurb.it.

Processing methods

Personal data are processed exclusively by automated tools for the time strictly necessary to achieve the purposes. The data is stored in the University of Urbino's computer system.

The personal data will be processed in the manner indicated by law (Art. 5 GDPR), which provides, among other things, that the data shall be

- processed in a lawful, correct and transparent manner ("lawfulness, correctness and transparency");
- collected for specified, explicit and legitimate purposes as set out above and subsequently processed in a way that is not incompatible with those purposes ("purpose limitation"); and
- adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed ("data minimisation"); and
- accurate and, where necessary, kept up to date; all reasonable steps will be taken to delete or rectify in a timely manner data that is
 inaccurate in relation to the purposes for which it is processed ("accuracy");
- retained until you request cancellation from the newsletter or from ISLL ("retention limitation");
- processed in a manner that ensures adequate security of personal data, including protection, by appropriate technical and organisational
 measures, against unauthorised or unlawful processing and accidental loss, destruction or damage ("integrity and confidentiality"). The
 processing will be carried out by computer or other electronic communications system, with organisational methods and logics strictly
 related to the purposes indicated. In particular, the site management software is constantly updated and regularly scanned for viruses
 and dangerous code.

The data may be subject to processing in anonymous form for the performance of statistical and research activities aimed at improving the services offered.

Use of Cookies

The management of the site uses a technology called "cookies", small text fragments that the website sends to the browser of the data subject, to be stored and retransmitted to the same site on the next visit.

The site makes use of "third party" content and services as a result of the incorporation of external resources or the implementation of technologies capable of extending its functionality and improving the browsing experience of its users. It is possible, therefore, that while visiting the site, some technical and/or profiling cookies are sent by third parties to the terminal used by users, without the Data Controller being aware of them or being able to intervene on them.

Categories of Authorised Parties and Recipients of personal data

Rights of the data subject

- the deletion of your data, with the exception of those contained in records that must be compulsorily kept by the University and unless there is an overriding legitimate reason to proceed with the processing as per Article 17 GDPR;
- a limitation of processing where one of the cases referred to in Article 18 GDPR applies.

You also have the right:

- to object to the processing of your personal data, without prejudice to what is provided for with regard to the necessity and obligatory nature of the processing for the purposes of establishing the relationship referred to in Article 21 GDPR;
- to revoke any consent given for non-compulsory data processing, without prejudice to the lawfulness of the processing based on the consent given before revocation.
