



Looking back on a year in which the construction of space was one of the themes that greatly engaged reflection within our network, we have chosen to accompany this ISLL Newsletter no.15 with some images that document the work that Giancarlo de Carlo did in Urbino between 1951 and 1994, particularly in the effort to recover the buildings in the historic center which became part of the university campus.

The true innovative significance of the project lay precisely in the idea of reconfiguring the city as a campus, intersecting the culture of the Renaissance with a modern language respectful of both the history of the city and the interpenetration between urban space and landscape that characterizes Urbino.

From the Paolo Volponi Scientific-Educational Area to the Department of Economy, Society, and Politics, from the Department of Law to the student residences outside the walls, we find all the themes of the city taken up: compressions, narrow passages, and views that open suddenly onto on a landscape suspended in time.

And still before our very eyes, this laboratory of experimentation in architecture and urban is once more investing in students as citizens of the future, so that they may be able to appreciate and learn from the open space of dialogue and transformation.
