Matthew H. Birkhold is Associate Professor of German at the Ohio State University and faculty Director of the Environmental Humanities minor. He is a scholar of law, culture, and the humanities, with an emphasis on German literature from 1750 to 1945, environmental humanities, intellectual property, and Indigenous studies. His main publications include *Characters before Copyright* (2019), *Chasing Icebergs* (2023), and *Metronome* (2025). He is also an enthusiastic teacher and advisor. His book *Chasing Icebergs* (2023) investigates the world of iceberg harvesting to learn if the frozen freshwater mountains could be a solution to the global water crisis. Interweaving cultural history, personal interviews, and law, it identifies the social, philosophical, legal, and environmental hurdles we must clear to equitably make use of this untapped resource.

Amitabh Vikram Dwivedi is the Dean of the Faculty of Humanities & Social Sciences at Shri Mata Vaishno Devi University, India. He is a linguistic anthropologist and cultural researcher whose work is defined by large, collaborative projects that document languages, revitalize marginal cultures, and map heritage practices.

He co-directed the Indian Council of Social Science Research project “A Comprehensive Study of Culture, Philosophy, Literature and Language of Jammu & Kashmir” (2018–2021), a multi-year effort combining field linguistics with regional cultural mapping. Beyond this flagship grant, Dwivedi has contributed to a wide slate of research and reference projects with international press(es).

Justine Scarlaken is a researcher and lecturer in contemporary literature at the University of Oviedo, Spain, specializing in ecopoetics, Pacific literatures, and theoretical fiction. Her research explores the intersections between literature, law, and legal innovation, with particular attention to feminist materialist and decolonial approaches. She has lived in New Zealand, an experience that deeply informs her work on Pacific Indigenous literatures and Māori sovereignty issues. Her recent publications examine how contemporary literature engages with legal and environmental concerns, as well as narrative strategies in texts addressing systemic violence.
